***Students who prefer English Language and Literature, American Culture and Literature, German Language and Literature, German Translation and Interpreting, English Translation and Interpreting, Tourism Guidance programs must take the Foreign Language Proficiency Exam. The Foreign Language Proficiency Exam will be held once, and candidates who do not take this exam will lose their right to choose these departments. In this respect, Candidates who will prefer these programs in any application period must take this exam.**

Candidates who have documents that are considered equivalent as specified in Ege University Foreign Language Teaching Directive must apply to our University's School of Foreign Languages www.ydy.ege.edu.tr until 07.07.2026 at the latest and have their documents approved for equivalence.

GENERAL EXPLANATIONS

Candidates must meet the application requirements at the time of application. Applying / being placed in our university does not give candidates any right that is not included in the law, statute, regulation and other legislation. The announcements made on the official web pages of our university have the force of notification to the candidates. Candidates applying to our university are responsible for the accuracy of all the information they declare and are deemed to have accepted the regulations in the guide and the relevant legislation. Each candidate will document the item marked on the application screen in accordance with his/her situation during registration. The application of the candidate who marks incorrectly, makes incomplete / false / misleading statements or fails to document his / her situation will not be taken into consideration, even if he / she is placed in a program, the legal responsibility will belong to the candidate, all rights arising from the placement will be deemed invalid, his / her registration will not be taken, and even if it is taken, his / her registration will be deleted regardless of the time elapsed.

In order for applications to be considered valid, candidates must comply with all the rules stated in this guide. Applications and placements of candidates who do not comply with these rules will be cancelled. Even after placement, if it is determined that a candidate has failed to comply with these rules, all rights arising from placement will be cancelled.

Applications and preferences to our university are made online only through the www.yutys.ege.edu.tr website on the dates specified in the Application, Preference, Placement and Registration Calendar. Applications made via e-mail, mail or other channels will not be accepted.

For candidates who will apply during the application periods, the application, preference and placement system will be opened to candidates in only 2 stages via the www.yutys.ege.edu.tr website:

-In the "**Application and Preference**" phase; candidates who will apply for the first time and candidates who were not placed in any program in the previous period can apply and make their preferences,

-At the "**Registrar's Office Review**" stage, the system will be opened to check those who have applied at the "Application and Preference" stage but could not make their preferences, to ensure the correction of those who applied on the application dates and uploaded missing/incorrect documents, and to review the uploaded documents, applications and preferences by our University. The system will not be opened to candidates during the "Registrar's Office Control" phase.

Turkish language with Latin letters shall be used in all correspondence/communication. Since all procedures must be completed within the specified deadlines, candidates must carefully follow their communication with the Registrar's Office throughout the application, preference, placement and e-registration process. Candidates who fail to complete their procedures within the specified period will lose their application and registration rights. The Registrar's Office shall not be responsible for returned/cancelled applications or delays arising from communication.

1.APPLICATION

1.1. Application Process

All candidates must submit their original passports during their applications (candidates who have a "T.R. Identity Card", "Temporary Protection Identity Document", "International Protection Status Holder Identity Document" can upload these IDs instead of their passports) TR- YÖS Exam Result Document and TR-YÖS Exam Application Form (TRNC nationals who will apply with a GCE AL score will be required to upload their GCE AL Result Document and its Turkish translation.) to the system and, where necessary, they will be asked to upload a document proving that they meet the application requirements. **Candidates with letter differences in their passport name and the names on the Exam Result Document will be asked to prove that they are the same person with the document. The applications of those who do**

not upload documents or upload missing/incorrect/unverifiable documents will be canceled. Candidates in this situation will be able to upload the correct documents instead of their missing/incorrect documents within the application period.

Since all transactions during the application process will take place via personal e-mail address, the candidate should not forget the e-mail address and password to be used. It will not be possible for the candidate to apply with an e-mail other than the e-mail used for the first login to the system.

Candidates first create a password on the www.yutys.ege.edu.tr website. A verification e-mail is sent to the e-mail address specified by the candidate when entering the application system.

The candidate clicks on the verification link sent in the e-mail and logs back into the system with his/her e-mail and the password he/she created. Whichever of the TR-YÖS exam results of the last 1 year (held on 19.10.2025 and 12.04.2026) or the GCE AL score converted into the TR-YÖS score system that the candidate has as of the application date, all placements in the three applications period made by our University are made on this score. Candidate; after reviewing the personal information on the screen, if there is no mistake, verify it and proceed to the questionnaire screen. After completing the questionnaire screen, the candidate uploads the necessary documents and enters their information on the screen that opens and waits for the system to be approved. The application of the candidate whose application is incomplete or incorrect will be returned by the authorized personnel. Candidates must correct the deficiencies stated in the reason for return and resubmit their applications for approval within the deadline.

The candidate, whose application is approved, fills out the preference form and selects the programs they prefer. The selected programs are checked and approved by the candidate. Candidates who have errors/problems in their information at any stage of the application process should contact Ege University Student Affairs Department Foreign Student Services Unit (uluslararasiogrenci@mail.ege.edu.tr , <https://oidb.ege.edu.tr>).

1.2.Filling out the Application Form

Candidates must carefully review the application requirements. In the “Application and Preference” stage, all candidates will be asked to enter their TR-YÖS/GCE AL Exam information, identity information (passport, gender, nationality...), high school information, contact information and upload a photo. The identity information entered by candidates on the application screen must be the same as the information in their passports. Each uploaded document must be checked by the candidate. Applications of candidates who enter their information incompletely or incorrectly; upload horizontal, blurry, incomplete, incorrect/unverifiable documents; or have inconsistencies in the information in their documents will be rejected.

➡ Photograph (Biometric ID Photograph taken within the last 6 months), Passport (Page with ID information and photograph) and TR-YÖS/GCE AL Exam result documents will be required to be uploaded to the system. Applications of candidates who do not upload documents, upload missing or invalid documents will be cancelled.

➡ “Foreign national” candidates will upload their passports as IDs, candidates with “Temporary Protection ID” or “International Protection Status Holder ID” will upload these IDs instead of their passports. Turkish national candidates will upload their passports or Turkish ID cards as IDs, and TRNC national candidates will upload their TRNC passports to the system. Blue Card holders will upload their passports as IDs.

➡ It is important for candidates to review the nationality information they entered during the “Application and Preference” stage. Dual nationality candidates who were foreign nationals by birth and later became Turkish citizens must have entered their first nationality, that is, the nationality of the foreign country, into the system. **Candidates who enter their nationality information incorrectly will not**

be registered to our University, and candidates who are later found to have entered their information incorrectly will have their registration deleted.

1.3.Applicants Who Can Apply

Candidates must meet the application requirements specified in the relevant articles on the application dates. In order to apply to the programs of our University, candidates must have received at least 200 points from any of the TR-YÖS exams held within the last one year as of the application date, namely the exams held on 19.10.2025 and 12.04.2026. TRNC nationals who have completed their secondary education in the TRNC and have a GCE AL exam result must have an A* result in Mathematics (140 points) and an A result (120 points) in at least two of the following subjects: Turkish, Physics, Chemistry or Biology.

For TRNC nationals who have completed all of their secondary education in the TRNC at a school that does not follow the Turkish curriculum and who apply to our University with a GCE AL exam result, the placement score is calculated by converting the GCE AL score into the TR-YÖS score system according to the following formula, using the sum of the Mathematics score and the scores in Turkish, Physics, Chemistry and Biology courses included in the GCE AL document.

$$\text{Placement score} = (\text{GCE AL Score} / 140 \times \text{Number of Courses Based on GCE AL Score}) \times 500$$

According to the Ege University Directive on the Principles of Admission of Students from Abroad, applications of candidates who are in the final year of secondary education or who have graduated will be accepted if they fall into one of the following categories:

a) Applications of foreign nationals, provided that they have not studied in or graduated from secondary education/high school institutions in Türkiye, will be accepted, excluding foreign nationals who have completed all of their high school education in Embassy Schools or international private educational institutions included in the MOBIS system, and foreign nationals who came to Türkiye within the framework of a project carried out by the Ministry of National Education or the Council of Higher Education.

(Candidates who have completed their high school education in Embassy Schools or international private educational institutions included in the MOBIS system will be required to combine and upload, as a single PDF file, an official letter obtained from their school stating that the school is an Embassy School or a school included in the MOBIS system, their high school diploma, and their transcripts for all years of high school.

Foreign nationals who came to Türkiye within the framework of a project carried out by the Ministry of National Education or the Council of Higher Education will be required to combine and upload, as a single PDF file, their high school diploma and an official letter obtained from their school stating that they were placed within the framework of the project.)

b) Applications of those who were citizens of the Republic of Türkiye (T.R.) by birth but lost their Turkish citizenship by obtaining permission from the Ministry of Interior to renounce Turkish citizenship, and those who can document that they hold a Blue Card issued upon request to those who lost Turkish citizenship, will be accepted, (provided that they have not studied in or graduated from secondary education/high school institutions in Türkiye or the TRNC). (Article 7 of the Turkish Citizenship Law No. 5901 states that “(1) A child born within the union of marriage to a Turkish citizen mother or father, whether in Türkiye or abroad, is a Turkish citizen.” Therefore, candidates who will apply to admission quotas from abroad are advised to review the Turkish Citizenship Law.

(Candidates in this category will be required to combine and upload, as a single PDF file, their high school diploma and their Blue Card; for those who renounced Turkish citizenship without obtaining a Blue Card, the decision document regarding renunciation of Turkish citizenship.)

c) Applications of those who acquired Turkish citizenship while they were foreign nationals / dual nationals in this situation will be accepted, provided that they have not studied in or graduated from secondary education/high school institutions in Türkiye or the TRNC.

(Candidates in this category will be required to combine and upload, as a single PDF file, the certified population registration document showing that they acquired Turkish citizenship and their high school diploma.)

d) Applications of Turkish nationals who completed all of their secondary education in a foreign country other than the TRNC will be accepted, including those who completed all of their secondary education in Turkish schools opened under the Ministry of National Education in a foreign country other than the TRNC.

(Candidates in this category will be required to combine and upload, as a single PDF file, the document showing that they received face-to-face education, the passport entry-exit document obtained via e-Government, the residence history document, transcripts for all years of high school, the high school diploma, and their Turkish translations certified by a notary public in Türkiye or by Turkish Embassies/Consulates abroad.)

e) Applications of TRNC nationals who have completed all of their secondary education in TRNC high schools and have or will have General Certificate of Education Advanced Level (GCE AL) exam results will be accepted, provided that they have not studied in or graduated from high schools in Türkiye or high schools in the TRNC that follow the Turkish curriculum.

(Candidates in this category will be required to combine and upload, as a single PDF file, the GCE AL result document, the document obtained from their school showing that they received education under the GCE AL curriculum, transcripts for all years of high school, and their high school diploma.)

- Applications of TRNC nationals who have completed all of their secondary education in a foreign country other than Türkiye and the TRNC and who have a TR-YÖS result will also be accepted.

(Candidates in this category will be required to combine and upload, as a single PDF file, their TR-YÖS document, high school diploma, and transcripts for all years of high school.)

f) Since it is essential that secondary education has been received while being present in the relevant country, those who graduated from the Ministry of National Education Open Education High School Abroad Program by documenting that they were present in the relevant country during the years corresponding to their secondary education may also apply to student admission quotas from abroad.

(Candidates in this category will be required to combine and upload, as a single PDF file, the passport entry-exit document obtained via e-Government, the residence history document, transcripts for all years of high school, the high school diploma, and their Turkish translations certified by a notary public in Türkiye or by Turkish Embassies/Consulates abroad.)

Applications of the following candidates will not be accepted:

a) Turkish nationals who completed all of their secondary education in Türkiye or the TRNC,

b) TRNC nationals / dual nationals one of whose nationalities is TRNC, except those who have completed all of their secondary education in TRNC high schools and have or will have General

Certificate of Education Advanced Level (GCE AL) exam results, provided that they have not studied in or graduated from high schools in Türkiye or high schools in the TRNC that follow the Turkish curriculum,

c) Dual nationals whose first nationality by birth is Turkish, except those who completed their secondary education in a foreign country other than Türkiye and the TRNC,

d) TRNC nationals, Turkish nationals, those who lost Turkish citizenship by obtaining permission to renounce Turkish citizenship, Blue Card holders, or dual nationals whose first nationality by birth is Turkish as defined in Article 7 of the Turkish Citizenship Law No. 5901, who studied in schools in Türkiye, schools affiliated with embassies in Türkiye, or foreign high schools in Türkiye.

PREFERENCES

1.4. Making Preferences

Applicants can choose from a maximum of five (5) different programs.

Candidates who will choose the Faculty of Medicine Program must have a score of 400 and above, candidates who will choose the Faculty of Engineering/Computer Engineering Program must have a score of 380 and above, candidates who will choose the Faculty of Dentistry, Pharmacy and Faculty of Letters/Psychology Program must have a score of 340 and above, candidates who will choose the Faculty of Health Sciences/Physiotherapy and Rehabilitation, Nutrition and Dietetics Programs and Faculty of Engineering/Electrical-Electronics Engineering, Bioengineering, Mechanical Engineering, Civil Engineering Programs must have a score of 320 and above, candidates who will choose the Faculty of Engineering/Chemical Engineering Program must have a score of 300 and above. Otherwise, the preferences made for the programs mentioned above will not be taken into consideration, and other preferences of the candidate that the conditions will be taken into consideration during the placement.

Candidates who have received a score of 200 or above and who prefer English Language and Literature, American Culture and Literature, German Language and Literature, German Translation and Interpreting, English Translation and Interpreting and Tourism Guidance must also take and pass the Foreign Language Proficiency Exam to be held by the School of Foreign Languages by receiving at least 70 out of 100. Otherwise, their preferences for these programs will not be taken into consideration.

→ Candidates who will choose the language programs listed above and have documents deemed equivalent in the Ege University Foreign Language Teaching Directive must apply to our University's School of Foreign Languages (www.ydy.ege.edu.tr) by 07.07.2026 at the latest and have their documents' equivalence confirmed.

Candidates who want to study in the Education Faculty Art Teaching program, which accepts students with a special talent exam, and the programs of the State Turkish Music Conservatory must have received a score of 200 or higher in the TR YÖS Exam and meet the requirements specified in the 1.3. Candidates Who Can Apply section of the guide. The candidates in question must also follow the relevant Faculty/College special talent exam calendar for the special talent exam and apply to the relevant school in person.

→ Placements to the programs of the Faculty of Sports Sciences will be made by ÖSYM through the Special Talent Exam (ÖZYES). The ÖZYES exam guide, application dates and exam dates can be accessed at www.osym.gov.tr.

→ When making a choice, candidates must carefully review the "Quota and Conditions" at the end of the guide. Candidates who do not meet the requirements for registration to programs that require special conditions cannot register for these programs.

Students registered to programs that require a foreign language preparatory class are required to comply with the Regulation on Foreign Language Education and Principles to be Followed in Foreign Language Education in Higher Education Institutions. Candidates who receive at least 70 points out of 100 from the proficiency exam conducted by our university or those who have sufficient points from exams accepted as equivalent to this exam by Ege University School of Foreign Languages are also exempted from preparatory education.

Otherwise, these students must continue with the Foreign Language Preparatory Class. The total duration of the Turkish/Foreign Language Preparatory education is a maximum of two years. The registration of students who cannot achieve language proficiency at the end of two years is cancelled.

➡ At the end of the application period specified in the application, preference and placement calendar, the preference procedures will be finalized and no changes can be made.

➡ Candidates who will apply to the special talent program can make choices for a maximum of five (5) different programs, excluding programs that accept students with a special talent exam.

2.PLACEMENT

2.1.Placement Procedures

Placements are made among candidates who have 200 or more points from TR-YÖS or TR- YÖS converted GCE AL score for programs that accept students with special talents, based on the Blended Talent Score (TR-YÖS/Created by taking 40% of the score in the 500-point system converted to TR-YÖS system and 60% of the special talent exam result to be conducted by the relevant unit). Placements are made for other programs based on the score submitted by the candidate from the TR-YÖS exam held in the last 1 year as of the application date/GCE AL score converted to TR-YÖS point system.

Candidates' TR-YÖS scores and GCE AL scores converted into the TR-YÖS score system are ranked from the highest to the lowest. Candidates with higher scores are placed in the programs of our University within the 20% country quota / quota number of the relevant program. For Blue Card holders applying to student admission quotas from abroad, candidates who were Turkish citizens by birth but lost their Turkish citizenship by obtaining permission from the Ministry of Interior, Turkish nationals who completed all of their high school education abroad except in the TRNC, and dual nationals in this situation one of whose nationalities is Turkish, placements in Teaching, Law, Medicine, Dentistry and Pharmacy programs are made up to 10% of the quotas of these programs.

Regardless of whether the candidate has taken the talent exam or not, the placement process starts with the candidate's first choice. In case of a tie in placement scores, the younger candidate is placed first, then the order of preference, and then the secondary school success score is taken into account.

For programs that accept students with special talent exams, placement is made according to the results of the "Blended Talent Score", starting from the highest score and up to the announced quota. In order for a candidate to be placed in programs that accept students with special talents, their blended talent score must be 200 or above.

➡ Candidates are placed in only one program. Candidates placed in a program cannot make preferences in other application periods of our university for that year. The first placement is the basis and subsequent placements are cancelled.

➡ In the same placement calendar, candidates can only register to another University by canceling their registration once, as per the decisions of YÖK. Therefore, a commitment document will be obtained from the candidates when registering to the e-registration system. The placements of the candidates who are later understood to have registered to our University by canceling their registration more than once will be cancelled, regardless of the time that has passed.

➡ Placements are made to vacant quotas due to lack of quotas or lack of applications in the 2nd and 3rd application periods according to the placement principles.

➡ If there are no applications for the quotas in any program or if the quotas are not filled, the quotas that are not filled or for which there are no applications will not be transferred to other program quotas.

2.2.Conclusion

Candidates will learn their placement results from <https://yutys.ege.edu.tr> by entering their username and password.

3. REGISTRATION

3.1. Registration Procedures

The registration process of the applicants who are enrolled in the undergraduate / associate degree programs of our university will be carried out in 2 stages.

3.1.1. Electronic Registration

Candidates who are placed must learn their student numbers and e-registration passwords from the result screen on the <https://yutys.ege.edu.tr> system. Students who do not complete the required procedures for registration within the specified period, do not submit their documents on time, submit incomplete/incorrect documents or documents whose validity cannot be verified, or are found to have made false/untrue statements shall lose their right to register, regardless of the time elapsed.

➡ Students who complete their e-registration but fail to send their documents to our Department within the specified period shall not acquire the right to final registration, and their e-registrations shall also be cancelled.

➡ Tuition fees shall be paid during registration renewal.

3.1.2. Submission/ Sending Registration Documents

Placed candidates first upload their registration documents electronically between the dates specified in the registration calendar. After the approval of the uploaded documents, they send the originals of the registration documents to the Registrar's Office by mail / cargo until the document delivery date announced on the website of our Presidency.

Accommodation, transportation, stationery, etc. expenses of the registered candidates will be covered by themselves.

REGISTRATION DOCUMENTS

- Separate “Registration Documents” pages have been prepared below under separate headings for candidates who are required to apply for a residence permit, for students who are citizens of the Republic of Türkiye/TRNC, and for Blue Card holders. Students who will carry out their registration procedures must print out the “Registration Documents” page under the heading appropriate to their status below, upload all their documents to the e-registration system, then prepare the originals of the following documents in a file and send them to Ege University Registrar’s Office by mail/cargo.
- The file must be prepared completely in accordance with the order of documents listed below. The document sequence number must be written on each document with a pencil, staples must not be used, the “Registration Documents” page below must be filled in and signed, then placed at the top of the file, and photographs must be attached with paper clips. All documents must be placed in a transparent plastic sleeve inside the file.
- Candidates must submit a document obtained from Turkish Language Teaching Centers/Units of universities in Türkiye, Yunus Emre Institute, or ÖSYM’s “Turkish as a Foreign Language Exam” (e-YDTS), showing that they have at least C1 level Turkish language proficiency. Candidates who graduated from Turkish high schools affiliated with the Ministry of National Education of the Republic of Türkiye are exempt from Turkish preparatory education. Students who are citizens of the TRNC are exempt from

Turkish preparatory education, provided that they submit a TRNC identity card and a transcript and diploma showing that they completed at least the last 3 (three) years of their secondary education in the relevant country, in educational institutions attended by the citizens of that country. Those who cannot provide Turkish language proficiency are obliged to raise their Turkish level to a sufficient level within 1 year, during which they will be deemed to be on leave, in order to start their education. By the beginning of the academic year following this period, they must document that they have at least C1 level Turkish language proficiency with a certificate obtained from Ege University Institute of Turkic World Studies Turkish Language Teaching Unit (TÖBİR).

- All foreign national candidates who will prefer the Vocational Schools listed below must document that they meet the following conditions.

*** For Urla Maritime Vocational School;**

* All candidates who will register for the Maritime Transportation and Management Program must:

- Meet the legal requirements regarding admission and health conditions in educational institutions as specified in the Seafarers and Maritime Pilots Regulation and the Seafarers and Maritime Pilots Training and Examination Directive. * Candidates who will register for the Aircraft Technology Program must meet the following conditions:

1. Not having any criminal record or criminal archive record that would prevent them from obtaining an airport entry card.
2. Obtaining a medical board report from a full-fledged hospital in Türkiye, issued within the last 6 months, stating that they do not have any health problem that would prevent them from performing the profession and/or the duties assigned in the profession, including but not limited to color blindness, hearing loss/deficiency, vision loss/deficiency, etc.
