

EGE UNIVERSITY 2024 SCHOLARSHIP STUDENT REGISTRATION GUIDE

The registration process of the candidates who are placed in our University as scholarship holders of the Presidency for Turks Abroad and Related Communities within the framework of the international student admission quota will be completed face to face at the Registrar's Office from **23 September 2024 until 25 November 2024**. Therefore, candidates must come to our Office with the registration documents specified below for registration.

REGISTRATION DOCUMENTS

FOR UNDERGRADUATE DEGREES

- 1.) 2 Biometric Photographs (photos must be taken within the last six months).
- 2.) The original Turkish translation of the page showing the identity information of the passport, certified by the Notary Public or the Turkish embassy in Turkey,
- 3.) A photocopy of the passport page containing identity information and visa information and all pages containing country entry and exit information
- 4.) Originals of High School Diploma and high school transcript
- 5.) Originals of the High School Diploma and Turkish translations of the transcript approved by the notary public in Turkey or the Turkish embassy
- 6.) The original of the High School Equivalency Certificate (If the candidate is in Turkey, it will be obtained from the Ministry of National Education or Provincial Directorate of National Education; if the candidate is outside Turkey, it will be obtained from the Turkish Embassy/Consulate in the country where the candidate is located.)
- 7.) Turkish C1 certificate, if available, obtained from the Turkish teaching centers of universities in Turkey or Yunus Emre Institutes abroad (candidates without the document will start their education from the language preparatory class)
- 8.) e-Residency Application Form obtained from www.goc.gov.tr website (will not be required from those who have acquired Turkish citizenship)
- 9.) Provision document proving that they have General Health Insurance (GSS) / document proving that they have taken out health insurance (Students who do not have a GSS provision document will fill out a petition for missing documents. Those who have acquired Turkish citizenship will not be required)
- 10.) Photocopy of the student visa or residence application form (residence application form will be filled out at e-ikamet.goc.gov.tr)
- 11.) Residence Permit. (It will be required from foreigners who have not obtained Turkish citizenship, students who do not have a residence permit will fill out a petition for missing documents, When they receive the residence permit card, they will submit a copy to our Office.)
- 12.) Originals with wet signatures of the information form and missing document petition ([click for information request form](#) , [click for missing documents form](#))

FOR MASTER/PHD DEGREES

- 1.) For those who will enroll in a master's program, a certified copy of the undergraduate diploma (must be certified by a Turkish notary in the country and by the Turkish embassy abroad)

- 2.) Certified copy of undergraduate and graduate diplomas for those who will enroll in a doctoral program (must be certified by a Turkish notary in the country and by the Turkish embassy abroad)
- 3.) For those who completed their undergraduate education abroad, a Turkish translation of the undergraduate diploma approved by notaries/Turkish embassies in Turkey
- 4.) For those who completed their master's degree abroad, a Turkish translation of the master's diploma approved by notaries / Turkish embassies in Turkey
- 5.) The original Turkish translation of the page showing the identity information of the passport, certified by the Notary Public or the Turkish embassy in Turkey
- 6.) A photocopy of the passport page containing identity information and visa information and all pages containing country entry and exit information.
- 7.) Provision document proving that they have General Health Insurance (GSS) / document proving that they have taken out health insurance (Students who do not have a GSS provision document will fill out a petition for missing documents. Those who have acquired Turkish citizenship will not be required)
- 8.) Photocopy of the student visa or residence application form (residence application form will be filled out at e-ikamet.goc.gov.tr)
- 9.) Residence Permit. (It will be required from foreigners who have not obtained Turkish citizenship, students who do not have a residence permit will fill out a petition for missing documents, when they receive the residence permit card, they will submit a copy to our Office.)
- 10.) Originals with wet signatures of the information form and missing document petition ([click for information request form](#) , [click for missing documents form](#))
- 11.) 2 Biometric Photographs (photos must be taken within the last six months).
- 12.) Turkish C1 certificate, if available, obtained from the Turkish teaching centers of universities in Turkey or Yunus Emre Institutes abroad (candidates without the document will start their education from the language preparatory class)

* Turkish Translations must be approved by notaries in Turkey or Turkish embassies

**Candidates who are missing high school equivalency certificate, residence permit, health report, GSS Provision Certificate can submit a missing document petition, provided that they submit the missing document within the specified period.

*** **Turkish/TRNC high school graduates will submit their high school diplomas instead of the equivalence certificate, TÖMER certificate and Turkish translation of the diploma.**

IMPORTANT

- After the documents are submitted in full, the student's status will appear as "active" in the registration system.
- Candidates who are required to obtain a Residence Permit will also apply to our University by completing the documents at the link <https://yu.ege.edu.tr/tr-19227/>.html as soon as possible.

CLASS IN WHICH REGISTERED CANDIDATES WILL START TRAINING

The duration of foreign language preparatory education, including Turkish, at our university is 2 years in total. The classes of registered candidates vary depending on their Turkish proficiency. Candidates who do not speak Turkish, do not have a Turkish C1 certificate or are not a Turkish high school graduate will have Turkish preparatory classes; these candidates cannot start first year classes.

Candidates who will receive Turkish and English preparatory training for one year after registering to our university will need to continue their education at our University's TÖBİR center. Candidates who have a Turkish C1/C2 certificate obtained from the language centers of universities in Turkey or Yunus Emre Institute and candidates who are Turkish high school graduates (including candidates who graduated from TRNC high schools) are exempt from Turkish. Candidates in this group will be able to start classes. In order to be considered exempt from Turkish, these candidates must hand in these documents (diplomas of Turkish/TRNC high school graduates) to the system. The class of those in this group who are enrolled in departments with a Compulsory English/German Preparatory program will be assigned as "0" (Language Preparatory Class).

FOREIGN LANGUAGE EXEMPTION EXAM AND REGISTRATION RENEWAL PROCEDURES

Date for foreign language exemption exam and for other detailed information, you can look at www.ydy.ege.edu.tr or contact the School of Foreign Languages. Students must apply for the exemption exam via the www.kimlik.ege.edu.tr system at least 2 weeks before the exam date.

Among the candidates who have completed the registration process, those who are enrolled in the English/German preparatory class or the 1st year will renew their registration/course selection within the registration renewal dates. Candidates can learn their registration renewal dates from the "Academic Calendar" section at www.kimlik.ege.edu.tr. Course selection will be made from the area titled "Registration Renewal (Course Selection)" in the www.kimlik.ege.edu.tr system. After selecting courses from the Opened Courses section

and adding the courses, candidates must complete the registration renewal process by sending the courses to the advisor for approval from the "Selected Courses" section.
